## **Cardinal Resources Limited**

## PRE-REINSTATEMENT DISCLOSURE

Cardinal Resources Limited (the "Company") will be reinstated to official quotation as from the commencement of trading on Thursday, 24 January 2013, following the Company's compliance with listing rule 11.1.3 and chapters 1 and 2 of the ASX listing rules.
