CARDINAL COMPLETES CAPITAL RAISING

Cardinal Resources Limited (ASX: CDV) (“**Cardinal**” or “**the Company**”) is pleased to confirm that it has completed a placement to sophisticated investors to raise a total of \$947,975 in capital through the issue of 14,584,231 fully paid ordinary shares (“**Shares**”) at \$0.065 with a free attaching listed option, exercisable at \$0.15 on or before 30 September 2019 (“**Listed Option**”), for every share subscribed for.

The free attaching options issued as part of this placement, exercisable at \$0.15 on or before 30 September 2019 are subject to shareholder approval. The Listed Options will be issued upon Shareholder approval being obtained.

In addition to the Placement, the Directors of the Company (namely, Messers Alec Pismiris, Archie Koimtsidis, Malik Easah and Marcus Michael) will subject to shareholder approval, participate in the placement to subscribe for a total of 2,607,693 Shares and 2,607,693 Listed Options for an aggregate subscription amount of \$169,500 (“**Director Placement**”). The Director Placement will be made on the same terms as the Placement.

The funds raised will be applied towards the Company’s Phase 1 and Phase 2 drill programs for the expanded areas to the north of the Namdini Mining Licence, as announced on 12 May 2015.

The Company will send a notice of meeting to shareholders in due course with respect to, amongst other things, the approvals required for the issue of the Listed Options as part of this Placement and the Director Placement.
